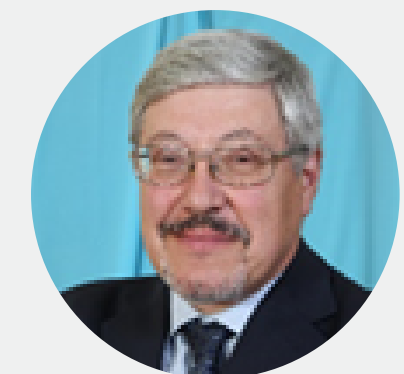

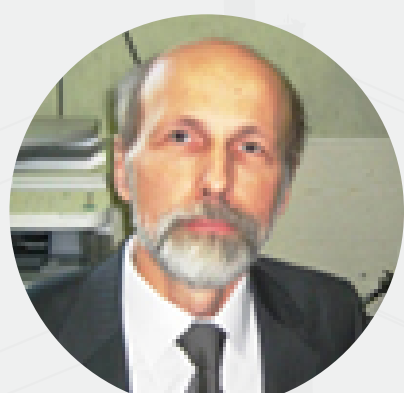

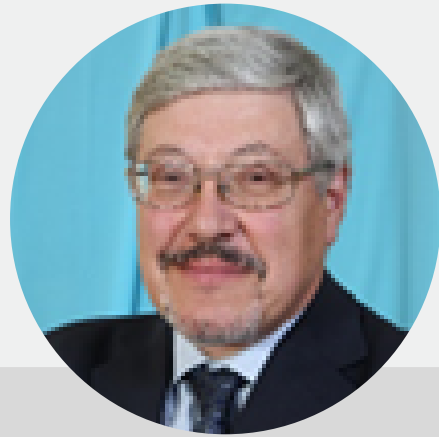

Prof. Sergei SUTYRIN graduated from Leningrad State University in 1974. Currently he is Professor and World Economy Department Head at St. Petersburg State University (SPSU), WTO chair holder since 2010. In addition to his professorship at SPSU Sutyurin has delivered lectures in several Universities in Finland, Germany, Japan. He is an author of more than 300 books, pamphlets and articles in different fields of economic theory. Sutyurin has been involved in many research and educational projects funded in particular by EU, DAAD, CIDA, International Trading Center.



Peter Zashev is an academic, business trainer and high-energy speaker on leadership, change and strategy. Peter has 18 years of executive education experience working with the management of big companies across Europe and mainly in the Nordic countries, the Baltic States and Russia. 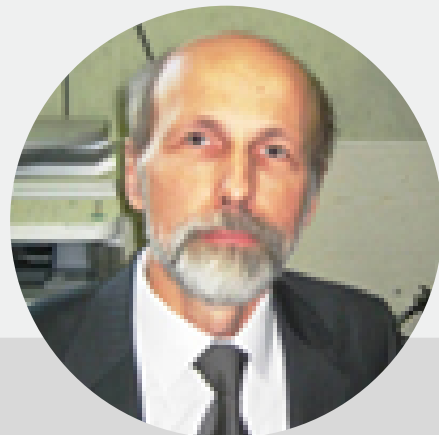

He is a non resident fellow at the World Trade Institute (Bern, Switzerland), senior associate at the Clingendael Academy (Den Haag, Netherlands), a fellow of the Institute for Globalization and International Regulation (Maastricht University, Netherlands) and the Salzburg Seminar (Austria). He holds a PhD from the Faculty of Law (Maastricht University), a master's degree in economics, finance and international trade (Tilburg University), a diploma from the Graduate Institute (Geneva) and the Ecole Nationale d'Administration (ENA-Paris). He managed the WTO Chairs Program (WCP) at the World Trade Organization, Geneva, Switzerland, working with leading scholars and think tanks from around the world.



Prof. Natalia Volgina Natalia Volgina is a Professor of the Department of International Economic Relations, Faculty of Economics, Peoples' Friendship University of Russia. She graduated from the Economics Faculty of Moscow State University. At her home University she reads a number of courses including "International Business" (for undergraduates), "International Economics" (for graduates), "Production Fragmentation and Global Value Chains" (for graduates). She also reads courses at the University of Nice Sophia-Antipolis (France) "Globalisation and International Economics" and International Transport (both for graduates). She also hold a position of visiting professor at the University of Cambridge (2018) with a course "Transport corridors, GVCs and economic opportunities for Central Asia". Natalia is a member of the Expert Commission of Higher Attestation Committee of the Ministry of Education and Science. The field of her academic interests is connected with the activity on multinational enterprises, international production, and global value chains. She is an author of research papers as well as a book International Production in Russia (2011), a co-author of a monograph Value Chains in the Automotive of Central and Eastern European Countries (2018), and a textbook titled International Economics (2006, 2010), International trade (2019) and International Finance (2020).

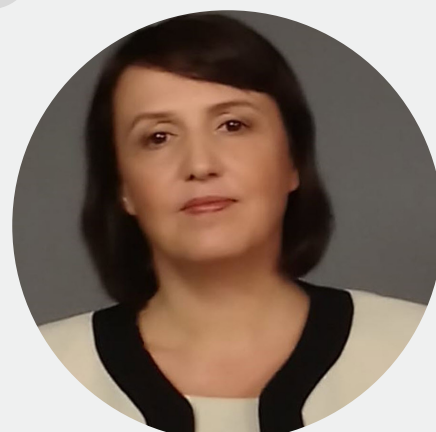

Ms. Tuerk holds a master's degree from the World Trade Institute (WTI) in Bern, Switzerland, and both a degree in international management and a degree in law from the Karl-Franzens Universität in Graz, Austria.



Werner Zdouc was Director of the WTO Appellate Body Secretariat from 2006 to 2020. Dr Zdouc joined the WTO Legal Affairs Division in 1995 and the Appellate Body Secretariat in 2001. In 2008 to 2009, he chaired the WTO Joint Advisory Committee to the Director-General. He has been a lecturer and visiting professor at Vienna Economic University, the Universities of St Gallen, Zurich, Barcelona, Yokohama, at Seoul National University, Fudan University Shanghai, the European Inter-University Centre for Human Rights and Democratization in Venice and the Geneva Graduate Institute. He is a member of the International Law Association. From 1987 to 1989, he worked for governmental and non-governmental development aid organisations in Austria and Latin America.



Mr. Dmitriy Tonkov is a counselor of the Permanent Mission of the Russian Federation to the World Trade Organization in Geneva dealing with trade remedies rules and industrial subsidies.
